# 1. Purpose

This policy sets out the safe working arrangements and expectations for elected councillors of St Cleer Parish Council when conducting visits to planning application sites. It ensures that visits are carried out safely, professionally, and in compliance with the control measures identified in the Council's Risk Assessment (RA).

## 2. Scope

This policy applies to all councillors undertaking official visits to view local planning application sites within the St Cleer Parish area, whether individually or as part of a group or convoy.

#### It covers:

- Travel to and between planning sites;
- Observation of sites from public areas; and
- Any limited interaction with premises owners or occupiers.



# 3. Planning and Authorisation

#### 1. Pre-Planning:

- All visits must be planned in advance wherever possible.
- A list of sites and an itinerary must be circulated to all participating councillors before travel.
  - Where a convoy is used, a lead vehicle and tail vehicle must be designated.

#### 2. Notification:

- Premises owners should be notified of intended visits wherever practicable to avoid unannounced attendance and potential confrontation.
  - Unannounced visits should be limited to viewing from public land or highways only.

#### 3. Briefing:

- Prior to any convoy or group visit, councillors must attend a safety briefing to review the route, communication protocols, and risk controls.

## 4. Conduct During Visits

#### 1. Safety First:

- Councillors must remain inside their vehicles unless it is safe and necessary to exit.
- All roadside observation must be conducted from pavements or safe verges, away from traffic flow.

#### 2. Personal Conduct:

- Councillors must remain professional, courteous, and non-confrontational.
- Any signs of aggressive or threatening behaviour must result in immediate withdrawal and reporting.

#### 3. Vehicle Operation:

- All vehicles must be roadworthy with valid MOT and insurance.
- Drivers must not drive under the influence of alcohol, drugs, or impairing medication.
- Mobile phones may be used hands-free only for essential communication.

# 4. Convoy Travel:

- Maintain safe following distances.
- The lead driver sets a consistent speed, and signals stops in advance.
- Hazard lights may be used where appropriate.
- Drivers must not overtake within the convoy.

#### 5. Parking:

- Park legally and safely without obstructing access or emergency routes.
- Use designated lay-bys or parking areas where available.

#### 6. Weather and Environmental Conditions:

- Visits should occur during daylight and in favourable weather.
- Visits must be postponed in severe weather (ice, heavy rain, high winds).



#### 5. Personal Protective Measures

- High-visibility clothing must be worn when outside vehicles.
- Appropriate non-slip footwear must be used.
- Avoid walking on uneven or unsafe surfaces.
- Use sunscreen and weather-appropriate clothing during prolonged outdoor visits.

# 6. Health and Wellbeing

- Take regular rest breaks and maintain hydration.
- Councillors feeling unwell or fatigued must not participate.
- Follow public health guidance (e.g., infection control) and maintain distance during interactions.

# 7. Emergency Procedures

- Carry a charged mobile phone and emergency contact numbers.
- In the event of an accident, breakdown, or confrontation, contact emergency services and inform the Clerk.
- Report all incidents, near misses, or hazards to the Clerk promptly.

# 8. Training and Review

- Councillors must read and acknowledge this policy and the associated Risk Assessment.
- Periodic refresher briefings will be provided.
- Review annually or sooner if incidents or new risks arise.

# 9. Accountability

Failure to comply may result in governance or disciplinary action under the Council's Code of Conduct.

The Parish Clerk is responsible for maintaining records of briefings, incident reports, and reviews.

## **RISK MATRIX**

- Orange Medium High Risk: Control measures are required to reduce risks to as low as reasonably practicable before initiating the process or task.
- Yellow Medium Low Risk: Control measures should be applied to mitigate risks to an acceptable level.
   Further evaluation may be necessary to determine if additional measures are required.
- Green Low and Acceptable Risk: Risks are deemed low and acceptable, with control measures already in place or not necessary.

Communicate with local emergency services prior to site visits to inform them of the convoy schedule and locations.
