

# PC13-19 | STRENGTHENING POLICE POWERS TO TACKLE UNAUTHORISED ENCAMPMENTS

#### Summary

The Home Office has issued a new consultation on strengthening police powers to tackle unauthorised encampments. The consultation covers criminalising the act of trespassing, broadening the existing categories of criminal trespass and broadening police powers to deal with trespassers. The main consultation document can be found <a href="here">here</a>.

#### Context

The government previously consulted on unauthorised developments and encampments in April 2018. Responses to this made clear that significant problems are created by many unauthorised encampments, including the sense of unease and intimidation residents feel when an unauthorised encampment occurs, the frustration at not being able to access amenities, public land and business premises, and the waste and cost that is left once the encampment has moved on.

The government also heard compelling evidence that stronger powers are needed to address the issues and concerns identified and that the majority of respondents believe the government should consider criminalising unauthorised encampments in England and Wales, by creating an offence of trespassing when setting up an unauthorised encampment. The government would now like to test the appetite to go further and broaden the existing categories of criminal trespass.

#### NALC's views

NALC is minded to use points made in response to the April 2018 consultation, as a steer to guide our new response. These include:

- All cases of unauthorised encampments should be criminalised on account of trespassing
- The police should have the power to direct trespassers to leave land as soon as it has been determined that they are there illegally
- The police should be able to take action regardless of the number of vehicles in the unauthorised encampment
- Principal authorities should have the power to demand the police attend as soon as an
  unauthorised encampment appears and to claim back costs incurred repairing damage
  caused by clearing up after unauthorised encampments

#### The Stocks

At the St Cleer Church PCC meeting yesterday evening it was confirmed that a PCC resolution had been passed confirming that the ownership of the stocks is with the Parish Council.

I enclose two copies of confirmation of this for our respective records, signed by the Revd Becca Bell. Can you please arrange for the forms to be signed on behalf of the Parish <u>Council</u>. Please insert the name of the person signing between the pencil crosses with the signature on the line below.

Please keep one copy for your records. As I mentioned earlier, I can arrange to collect the PCC copy from your Chairman.

If the Parish Council is willing to loan the stocks to the Museum, there will be paperwork to complete. I enclose the Museum's Object Entry Form in triplicate. Can the relevant person please sign under Reason for Entry. I have signed on behalf of the Museum. The usual loan period is 12 months but it can be less if you wish and can be extended for a further period. Please keep the pink copy for your records.

Also (sorry about this!) there is a Loan-in Agreement which sets out more information. Could you please indicate whether you would like the Parish Council acknowledged on any labels or publicity? There has been a sign by the stocks with a brief history saying that they were loaned by the PCC. A new sign can easily be prepared.

Will you please arrange for the form to be signed and the name <u>printed</u>. You may want to copy this for your records. If possible, can you please return the Museum forms to the Museum in Pike Street, Liskeard – in the same building as the Tourist Information Centre. The Loan-in Terms and Conditions are for you to keep.

I have dated all the paperwork the 1 October 2019 for simplicity.
